The eMobility Construction Manager works alongside the Engineering and Interconnection Manager and Operations Manager to foster great client relationships. Day to day activities include supervision of all on-site construction, including sub-contractors on the job, resolving day-to-day problems on the job site, and inspecting all work before and during construction to ensure compliance with plans and specifications. Works with the Contracts and Procurement Manager to solicit, review and award contracted work. This position seeks motivated, organized, and independent-minded individuals who will work to accomplish major project milestones while coordinating due dates and tracking information that is crucial to project success.

This position will be located in our Morristown, New Jersey Office but will require travel to Current's electric vehicle charging deployments throughout the United States.

### **Specific duties:**

- Perform fundamental project management practices such as construction progress tracking, simple progress & financial forecasting, document management, problem solving, dispute resolution, design troubleshooting, and value engineering.
- Manages scope changes through change order policy, requests for information ("RFIs"), submittal logs, and applications for payment.
- Leads and enforces the safety policies and procedures and addresses non-compliance among all employees, subcontractors, and vendors on project sites.
